

Job Summary:

The job of Senior Programmer Analyst was established for the purpose/s of leading a programming team(s) in developing complex computer applications using a variety of hardware and software tools to automate specific processes at Tulare County Office of Education (TCOE). This position reports to the position(s) of Application Manager and/or Director of Information Systems (IS) with the work assignment being in any required department/division within TCOE. The duties may include facilitating the development, installation and/or implementation of various software applications including web-based, personal computer-based, mobile-based and/or third party as a team lead, or as an individual. Incumbents may be responsible for more than one application system on an individual basis and/or as a team lead during development, implementation and/or maintenance.

Essential Functions:

- ▶ Coordinates software application development, implementation and production environments for the purpose of meeting TCOE staff needs.
- ▶ Leads/Develops/Maintains software projects including web-based applications, windows-based applications, integration applications and services for the purpose of facilitating TCOE operations.
- ▶ Provides support on in-house software packages for the purpose of training/educating TCOE staff.
- ▶ Works under the direction of the Application Manager(s) as part of a team for the purpose of ensuring a common, consistent, extensible programming platform for development and maintenance.
- ▶ Works with other Information Systems and/or TCOE staff for the purpose of developing software requirements, designing and testing documentation for TCOE applications.
- ▶ Writes/Maintains system and infrastructure documentation as needed for the purpose of facilitating TCOE functionality.
- ▶ Leads programming teams in software application development, implementation and production environments for the purpose of meeting TCOE staff needs.
- ▶ Leads/Develops/Maintains software projects including web-based applications, windows-based applications, integration applications and services for the purpose of facilitating TCOE operations.
- ▶ Leads support on in-house software packages for the purpose of training/educating TCOE staff.
- ▶ Works with other Information Systems and/or TCOE staff for the purpose of developing software requirements, designing and testing documentation for TCOE applications.
- ▶ Writes/Maintains system and infrastructure documentation as needed for the purpose of facilitating TCOE functionality.
- ▶ Works under the direction of the Application Manager(s) and/or Director of Information Systems as a programming team lead for the purpose of ensuring a common, consistent, extensible programming platform for development and maintenance.

 - complex n-tier application development;
 - content management system experience is desirable;
 - mobile platform experience is desirable;
 - intermediate level servers;
- ▶ **Ability to:**
 - lead programming team(s);
 - design and develop n-tier software applications utilizing platforms such as .Net, C# and other current technologies;
 - administer, design and develop database technologies using industry standard SQL techniques;
 - instruct in the usage of current technologies;
 - communicate orally and in writing.

Responsibilities include: working independently under broad organizational guidelines to achieve unit objectives; leading, guiding, and/or coordinating others; and operating within a defined budget. Utilization of significant resources from other work units is routinely required to perform the job's functions. There is a continual opportunity to significantly impact the Organization's services. The usual and customary methods of performing the job's functions require the following physical demands: some lifting, carrying, pushing, and/or pulling; and significant fine finger dexterity. Generally the job requires 75% sitting, 10% walking, and 15% standing. This job is performed in a generally clean and healthy environment. Job related experience within specialized field with increasing levels of responsibility is required.

Education Required:

- ▶ High school diploma.
- ▶ Bachelors degree in job-related area.
- ▶ Two years of verifiable experience as a programmer can be substituted for each year of formal education.

Experience Required:

- ▶ Eight years of experience as a programmer in application design, implementation and support.
