The County Committee meeting was called to order by Chairman, Joe Hallmeyer at 8:39 p.m.

**MEMBERS ABSENT** Victor Pérez – he declined to seek another term.

**NEW COMMITTEE

**MINUTES** A motion was made by Mickey Hirni, seconded by Melissa Janes and carried unanimously to approve the minutes of March 18, 2015 (Citrus South Tule School District meeting) as written.

ASSEMBLY BILL 331  
OVERVIEW

Desiree Serrano presented Assembly Bill 331 (2015) which amends Education Code section 5019 as potential county committee activity. The amendment authorizes school districts with an ADA of less than 300 students to decrease their board membership from 5 members to 3. This change can be initiated in one of three ways: 1) a petition of the electorate; 2) a resolution of the school district governing board requesting the decrease; or 3) the county committee could pass a resolution to change the board membership from 5 members to 3. If the county committee receives a request for decrease, this would trigger a public hearing of the county committee that would take place within the boundaries of the school district that made the request. The committee would approve or disapprove the request at the end of the public hearing.

There are potentially 6 districts in Tulare County that could be eligible to request a reduction. None of the potential districts have trustee area based elections; they are at-large.

ADJOURN

Mr. Vidak announced that John Caudle retired earlier this year and introduced Dr. Craig Wheaton to the committee as his replacement. Dr. Wheaton will start in February 2016.

As there was no further business, Chairman Hallmeyer adjourned the meeting at 8:48 p.m.

WHEREAS, Education Code section 5019 requires a school board to maintain a membership of three, five, or seven members;

WHEREAS, the Allensworth Elementary School District currently has a five member Board of Trustees;

WHEREAS, one of the five members of the Governing Board ("Board") of the Allensworth Elementary School District ("District") resigned;

WHEREAS, the Board's membership may be reduced to three individuals because its average daily attendance was less than 300 during the preceding year;

WHEREAS, the District has a small population, and the best interests of its students, employees, and community will be served by having a Board of three members;

WHEREAS, after a proposal has been made to decrease the membership of a school district's board, the County Committee on School District Organization ("County Committee") must conduct at least one hearing on the matter in the boundaries of the respective district, and, at the conclusion of the hearing, approve or disapprove the proposal pursuant to Education Code section 5019, subdivision (c)(2);


BE IT RESOLVED, that the District proposes that the County Committee adopt a resolution reducing the membership of the Board of the District from five (5) members to three (3).



Resolution Approving Allensworth School  
District's Proposal to Decrease Board  
Membership

Resolution No. 2016-1

**WHEREAS**, Education Code section 5019 requires a school board to maintain a membership of three, five, or seven members;

**WHEREAS**, the Allensworth Elementary School District ("District") currently maintains a five member Governing Board ("Board");

**WHEREAS**, Board member Kayode Kadara was appointed in lieu of election in 2012 for a four year term ending in 2016;

**WHEREAS**, Board member Adrian Santiel was appointed to fill a vacant seat in 2014, for a two year term ending in 2016;

**WHEREAS**, Board member Nancy Nunez was appointed in lieu of election in 2014 for a four year term ending in 2018;

**WHEREAS**, Board member Goana Toscana was appointed in lieu of election in 2014 for a four year term ending in 2018;

**WHEREAS**, Board member Melissa Diaz was appointed in lieu of election in 2014 for a four year term ending in 2018;

**WHEREAS**, the District has a small population, and has historically struggled to fill and maintain its five member board;

**WHEREAS**, on October 15, 2015 a Board vacancy was created when Board member Melissa Diaz submitted her resignation to the Tulare County Superintendent of Schools ("County Superintendent");

**WHEREAS**, after diligent efforts, the District was unable to find a single qualified individual interested in filling the vacancy, and therefore the District was unable to make a provisional appointment within the 60 day time allotment (Ed. Code § 5091, subd (a)(1));

**WHEREAS**, due to the District's inability to make a provisional appointment, the County Superintendent was required by law to order an election with the Tulare County Registrar of Voters-Elections Division to fill the vacancy (Ed. Code § 5091, subd (a)(2));

**WHEREAS** upon receipt of the order of election, the Tulare County Registrar of Voters-Elections Division scheduled an election for June 7, 2016. No individual filed a declaration of candidacy, and therefore no election will be held (Elec. Code § 10603; Ed. Code § 5326);

**WHEREAS**, another Board vacancy will be created in the coming months as Board member Adrian Santiel has provided the District with his letter of resignation, and directed the Board and Superintendent to submit the letter of resignation to the County Superintendent at a time that best benefits the District in light of the proposed reduction in Board membership;

**WHEREAS**, in light of the District's current and historical struggles to fill and maintain its five member Board, on February 2, 2016, the Board determined that it is in the best interests of its students, employees, and community to reduce Board membership to three. The District's Board adopted Resolution No. 3320-93, proposing a reduction in Board members from five to three (Exhibit B);

**WHEREAS**, Education Code sections 5019 and 5020 authorize the Tulare County Committee on School District Organization ("County Committee") to decrease a school board's membership in a school district under its jurisdiction;

**WHEREAS**, pursuant to Education Code section 5019, subdivision (a)(2), the Board's membership may be reduced to three members because its average daily attendance was less than 300 during the preceding year;

**WHEREAS**, should the proposed reduction in Board membership be approved, there will be no staggering issue, as Board member Kayode Kadara's seat will be up for election in 2016 and Board members Nancy Nunez and Goana Toscana's seats will be up for election in 2018;

**WHEREAS**, in the judgment of the County Committee, the best interests of the District's students, employees, and community will be served by having a Board of three members;

**WHEREAS**, if the County Committee approves the District's request to reduce the number of Board members, Education Code section 5020 requires the County Committee's resolution of approval to be submitted to the electorate for its approval;

**WHEREAS**, an election to approve the proposed reduction in Board members will result in a cost to the District;

**WHEREAS**, Education Code sections 33050-33053 authorize the State Board of Education to waive this voter approval requirement, which could reduce the costs associated with this proposed change in Board size;

**WHEREAS**, on March 8, 2016, after a public hearing on the matter, the District's Board adopted a Resolution directing the District to seek a full waiver of this election requirement;

**WHEREAS**, on March 11, 2016, the District submitted the waiver request to the State Board of Education;

**WHEREAS**, the State Board of Education is expected to hear the waiver request at their regularly scheduled May 11-May 12 board meeting; and

**WHEREAS**, on May 4, 2016, the County Committee held a public hearing in the Allensworth School District, as prescribed by Education Code section 5019, on the District's proposal to reduce the size of the Board to three members.

**THEREFORE**, the County Committee hereby finds and resolves as follows:

1. All requirements of law have been met to allow the County Committee to approve or disapprove the District's proposal to decrease the District's Board membership from five to three;
2. The District's proposal is supported by the District's Board without public opposition;
3. The County Committee hereby approves the proposed reduction in the Allensworth School District's Board of Trustees from five members to three members;
4. By operation of law, this Resolution constitutes an order of election, unless the Allensworth School District obtains the State Board of Education waiver (Ed. Code § 5020, subd. (a); Ed. Code § 33050 *et seq.*); and
5. The Tulare County Office of Education Superintendent/designee are hereby authorized and directed to take any other actions necessary to effectuate the purposes of this Resolution.
