Minutes

Joe Martinez presented the first reading of Board/Superintendent Policy and Administrative Regulation 6173 - Education of Homeless Children. The major change to the language is moving from identifying homeless student to identifying students who are experiencing homelessness. For the 2024-2025 school year, there were 4,746 students identified as experiencing homelessness which is a 14% increase from the previous year. In TCOE run schools, there were 45 youth who identified as experiencing homelessness which is about double the previous year. This is an informational item only.

2. Consideration and Approval, Tulare County Creative Blueprint for Arts Education - Kate Stover

Minutes

Kate Stover announced that October is Arts Education Month. She presented the Tulare County Creative Blueprint for Arts Education. She shared that planning for the arts master plan began in 2017. The Board approved it in March

of 2019. The CreateTC coalition was formed. In September 2021, TCOE received a \$1.7 million grant for The QUAIL (Quality Arts Instruction and Learning) Project. This year is the fifth year of the grant, and it is fully funded. With this funding, 48 districts, including charters, 143 school sites and over 1,000 educators have been supported. In 2023, Ms. Stover presented the work being done in Tulare County to U.S. Department of Education. She shared information about the Young People's Concerts and the purchase of over 1,600 new print digital media books, puppets, and kits in English and Spanish. Currently, she is working regionally to implement the first Strategic Arts plan in the state. Planning for the Creative Blueprint for Arts Education began last year with the goal of making sure all students have access to the arts by adding innovative initiatives. She introduced members of the planning team who were in attendance, Amy King, Amie Rangel, and Travis Walters.

The Board thanked Ms. Stover for her presentation and the work being done.
