

Redwood was coached by Tina Moran and Paul Freeborn, with assistance from attorney coaches Andre Gaston, Peter Park, Josh Fox, Sara Allen, Edward Cobian Pinto, Zackery Michaelson, and Doug Fulmer.

This year's case was People v. Gold, and for the finals Redwood acted as the defense while Golden West was the prosecution. People v. Gold is the trial of Logan Gold, assistant campaign manager to their spouse, Harper Dorais, who is a candidate for city council in the rural mountain town of Emerald Bend, California. Gold is charged with the kidnapping of Taylor Alexander, a rival candidate to Dorais in the city council election.

Also announced as winners following the Mock Trial Finals were the winners of the courtroom artists competition and the courtroom journalist competition.

In the courtroom artists competition, the winning artists advancing to the state competition are Wen He and Isabelle Wu of Redwood High School.



The winning courtroom journalist advancing to the state competition is <u>Trinity Elliot</u> of Exeter Union High School.

The state competition will be held March 14-16 in Los Angeles.

## School Safety Program to host first School Safety Symposium March 5



Registration is now open for TCOE's first School Safety Symposium. Scheduled for Wednesday, March 5, the full-day conference will feature a number of nationally known speakers on the subject of school safety.

The conference will begin with a keynote presentation from Kristina Anderson, founder and executive director of the Koshka Foundation for Safe Schools. She started the non-profit after surviving the 2007 Virginia Tech school tragedy, where she was shot three times. Anderson is also co-founder of LiveSafe, a mobile technology communication platform for sharing safety-related information. It is used by over 100 college campuses, as well as corporations and hospitals.

In the afternoon, attendees will hear from Nicole Hockley, co-founder and co-CEO of Sandy Hook Promise. In the aftermath of the Sandy Hook Elementary School tragedy, which claimed the life of her youngest son, Dylan, Hockley created Sandy Hook Promise Foundation to educate and empower youth and adults to prevent violence in schools, homes, and communities. Under her leadership, the research-driven Know The Signs violence prevention programs were created and are now available to schools at no cost. More than 31 million have participated in these life-saving programs in

34,000+ schools and youth organizations nationwide. As a result, countless acts of violence have been averted – including at least 16 planned school attacks.

The conference will feature breakout sessions with presentations conducted by members of Sandy Hook Promise, TCOE's School Safety Program, the Federal Bureau of Investigation (FBI), the Tulare County District Attorney and Tulare County Probation departments, retired Aztec High School (New Mexico) superintendent Kirk Carpenter, and Association of Threat Assessment Professionals president Dave Okada.
