

Overview

General Overview of Early Retirement Incentives

Benefits Include:

- Avoiding layoffs
- Lowering costs

Incentives must be used for a legitimate non-discriminatory reason.

If offered to a represented employee, District needs to negotiate those terms with union.



Early Retirement Incentives Considerations

When a school district is deciding whether to offer an early retirement incentive it is important to consider:

- What type of incentive will be offered?
- What qualification requirements will be required for an employee to be eligible for the incentive?
- Which employee groups which will be offered the incentive?

Cash payment

Employer contribution to a retirement plan on the employee's behalf

Step-by-Step Approval Process

1. Speak with Board about Incentives

2. Notify the Union and negotiate the terms of the Incentive

3. Take MOU and Resolution to Board for approval

4. Notify employees of Incentives


