IPM statement

It is the goal of LA SIERRA MILITARY ACADEMY to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

We will maintain a clean campus through monthly pest prevention for the safety of the cadets, families and staff we represent and serve.

Pest identification, monitoring and inspection

Terminix and results are communicated to the IPM Coordinator.

Terminix completes their monthly inspections and treatments during times when school is not in session. Notices regarding areas designated for treatment are flagged to school staff for situational awareness and safety. Our site custodian ensures that all areas treated are ready for daily school use, once the treatment ordinances are applied for school safety measures.

¹ These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
